Overview and Applicability

This Disclosure Statement is provided to private clients¹ of JPMorgan Chase Bank, N.A. or one of its affiliates (together "J.P. Morgan") whose investment management accounts, advisory accounts² or trust accounts for which J.P. Morgan serves as trustee, may be invested in one or more series of certain mutual funds managed by parties that are not affiliated with JPMorgan Chase & Co. (each a "Third-Party Fund" or "Fund" and, collectively, the "Third-Party Funds" or "Funds"). However, this Disclosure Statement is not applicable to charitable trusts for which J.P. Morgan is acting as the trustee, or where J.P. Morgan is acting as the trustee subject to the laws of one of the following jurisdictions: California, Louisiana, New Hampshire, New York, South Dakota, Wyoming and any jurisdiction outside of the United States.

The Disclosure Statement is also not applicable to Investment Management accounts where the account assets are held by a custodian other than J.P. Morgan.

This Disclosure Statement contains certain information about Third-Party Funds, including information about the services that J.P. Morgan may provide to the Funds, and the compensation they receive with regard to those services. This compensation is generally known as "indirect compensation" because it is received from a source other than your account.

■ GENERAL INFORMATION ABOUT THIRD-PARTY FUNDS

The Funds are open-end investment companies managed in various investment styles and offered for sale in multiple classes. This Disclosure Statement is not an offer to sell shares of any Fund. For more information about any specific Fund, you may read the applicable prospectus, which generally contains information about the Fund's investment objectives and risks, and charges and expenses associated with the Fund. Prospectuses and other Fund information may be obtained by calling your J.P. Morgan team.

The Funds are not deposits or obligations of, and are not guaranteed by, J.P. Morgan or any other bank. Investments in the Funds involve investment risks, including possible loss of principal amount invested. The Funds are not insured or guaranteed by the Federal Deposit Insurance Corporation ("FDIC") or by any other governmental agency or government-sponsored agency of the U.S. government or any state.

All domestic mutual fund transactions are cleared through J.P. Morgan Securities LLC ("JPMS"), with the exception of certain domestic money market funds transactions, which are cleared through JPMorgan Chase Bank, N.A. When JPMS clears domestic funds for JPMorgan Chase Bank, N.A., JPMS is reimbursed by JPMorgan Chase Bank, N.A. at JPMorgan Chase Bank, N.A. sown expense and out of its own profits for the cost of performing this service.

Share Class

The share class for which an account is eligible generally will depend on the share classes offered by that Fund, certain eligibility requirements outlined in the applicable Fund's prospectus and/or statement of additional information, and other criteria that may be applied by a financial intermediary, if applicable. J.P. Morgan, as an institutional investor acting in a fiduciary, advisory, custodial, agency or other capacity, will negotiate at the program level to seek to obtain the most appropriate share class available from each third-party mutual fund provider, with the goal of obtaining a minimum-waived, institutional-level share class. Contact your J.P. Morgan team if you have questions about the share class for which your account may be eligible.

Administrative Servicing Fees

Financial intermediaries, including J.P. Morgan, enter into agreements with the Funds, their investment managers, distributors, principal underwriters, shareholder servicing agents and/or other affiliates of the Funds. The Funds or these Fund affiliates may pay J.P. Morgan fees for providing certain administrative services, which may include, but are not limited to, maintaining and updating separate records for each client with respect to share prices and balances and any assessed charges; preparing and delivering client statements; tax reporting; proxy voting and solicitation; processing purchase and redemption orders; processing dividends; and distributing prospectuses and other Fund reports.

These fees may be referred to as "administrative servicing fees," or "shareholder servicing fees" or "sub-transfer agency fees." They may also be referred to as "revenue sharing" when they are not paid from a Fund's assets but instead paid by a Fund's affiliate from that affiliate's own resources. The fees are based on the amount of a Fund's shares owned by J.P. Morgan clients. J.P. Morgan receives such fees at an annualized rate of up to 0.25% for as long as a Fund is held in a J.P. Morgan account. Payments are generally received by J.P. Morgan on a monthly or quarterly basis and are calculated based on the daily net asset value of the covered assets. J.P. Morgan currently receives such payments in connection with investments in the Third-Party Funds listed below.³
